MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (MOU) has been executed on 28th July, 2022.

between:

1. COSKILLS.IN

An Ed-Tech platform endowing aspirants an avenue to cultivate skillsets through unique hands-on learning programmes. Company incorporated under the section 58(1) of the Indian Partnership Act, 1932, having its principal office at 23A-3-32, 2nd Floor, Lalitha & Co Building, R R Pet, Eluru-534002, Eluru Dist., Andhra Pradesh, India, and established on 29th April 2021.

2. CH.S.D.ST.THERESA'S COLLEGE FOR WOMEN (AUTONOMOUS)

A model institution for higher education which strives to create empowered women through substantial academic enlightenment. The institution, affiliated to Adikavi Nannaya University, is located at Gavaravaram, Sanivarapu Peta, Eluru-534003, Eluru Dist., Andhra Pradesh, India, and was established on 5th July 1953.

'Coskills.in' & 'CH.S.D.St.Theresa's (A) College for Women' are hereinafter referred to individually as "Party" and collectively as 'Parties'.

WHEREAS,

- A) COSKILLS.IN is an Ed-Tech company steadfast in furnishing professionals with the finest skillset through their pragmatic programs which facilitate a 360° learning experience.
- B) CH.S.D.ST.THERESA'S COLLEGE FOR WOMEN(A) is an Educational Institute that transforms students through its innovative co-curricular & extra-curricular programs.

NOW, THEREFORE, in recognition of their common interests and objectives, and in order to supplement and strengthen the existing understandings amongst the Parties with respect to cooperation and mutual exchange of technical services and Supportive economical elements, the Parties confirm their mutual understanding of the following:

ARTICLE-1 PURPOSE

- 1.1 The Purpose of this MOU is to render versatile means and channels that refine students' academic credentials and strengthen social & life skills which prepare students to conquer the complex and highly technical world and pave the way to their prosperous careers.



- 1.2 The purpose of this MOU is strictly limited to expressing a desire of the Parties for mutual cooperation, and is not intended to impose any legal obligation of any nature on either Party.
- 1.3 This MOU shall not in any manner supersede the existing understandings and other arrangements between the Parties.

ARTICLE-2 SCOPE OF COOPERATION AND PERIOD OF TIME

Within the context of their respective mandates, objectives, and procedures, the Parties shall cooperate in the following areas:

- (a) Implementing academic programs that contribute to aspirants' versatile skill development;
- (b) Developing and implementing appropriate joint programs and projects in concern with the educational institutions;
- (c) Organizing workshops, awareness sessions, and training services jointly and
- (d) Exchanging analytical reports, publications, technical materials, expert services, and other information related to the purposes of this MOU.
- (e) The period of MOU may be extendable up to 3 years from the date of undersigned by the respective Authorities on mutual consult.
- (f) The Company Coskills.in will provide Training & Placement assistance to the aspirants from the CH.S.D.Theresa's College for Women(A) those who are willing to register under the Training & Placement program as per applied conditions* of the company skills.in.

*Placement will be provided to the aspirants who are well trained on specific technical/management/Designing course or qualification & Skills which to meet coskills.in requirements.

* If Training is required or needed to provide, fees or charges may apply by coskills.in on mutual consent

ARTICLE-3 OBJECTIVES

Cooperation between the Parties under this MOU is based on the overarching mutual recognition of:

- (a) The need for endowing aspirants an avenue to cultivate their skillset for retentive development;
- (b) The need for optimally channelizing students' competency to their full potential
- (c) The need for designing, implementing, and maintaining result-oriented development policies and programs. (For all the students)





ARTICLE-4 FOCUS OF JOINT ACTIVITIES

- 4.1 With a view to achieving the purposes of the MOU, the Parties intend to:
- (a) Identify the training needed aspirants for achieving university objectives;
 - (b) Access to an external ecosystem across streams like skill-building, internships, employment, entrepreneurship, Project-based learning programs, etc.
 - (c) Promote the development of International standardized training services and workshops;
 - (d) Assist the institute in formulating and implementing policies, plans, and strategies aimed at accelerating investment in the needed organizations
 - (e) Promote the development of expedient educational training modules as a comprehensive approach to addressing both infrastructure development and facilitation measures to increase the efficiency of the students in the institutions;
- 4.2 The above-mentioned areas may be amended from time to time with the mutual written consent of the Parties.

ARTICLE-5 EXCHANGE OF INFORMATION

The Parties recognize that effective cooperation depends on an open, comprehensive, and regular exchange of information. To the extent possible in accordance with their respective policies concerning disclosure of information, the Parties intend to make appropriate arrangements to:

- (a) exchange copies of publications and all formal documents related to the agreed policies, and
- (b) exchange information posted on their respective websites of conferences, seminars, and workshops being organized or sponsored as per agreed terms;

ARTICLE-6 RECIPROCAL INVITATIONS

The Parties recognize that appropriate representation is important to emphasize their common interests, purposes, and intentions in substantive terms. The Parties, therefore, intend to invite each other, where appropriate, to meetings, conferences, seminars, and workshops relevant to cooperation in the priority areas set out in this MOU.

ARTICLE-7 PERIODIC CONSULTATIONS

The Parties recognize the significance of convening periodic mutual consultations to review the planned, ongoing, implemented, and achieved activities under this MOU, evaluate the results of such activities, and explore and discuss new challenges, opportunities, and problems related to the areas of cooperation under this MOU. It is the understanding of the Parties that such consultations shall be conducted periodically as and when required but not less than once a year.





ARTICLE-8 FOCAL POINTS

ARTICLE-9 PREPARATION, IMPLEMENTATION AND EVALUATION OF ACTIVITIES

- 9.1 The Parties will endeavor to prepare:
- A list of all current operational cooperation activities and their status of implementation;
 - A list with a brief description of all planned cooperation activities for the next years; and
- 9.2 The Parties will endeavor to ensure that:
- Their respective appropriate program managers will be responsible for the implementation of cooperation activities listed within their areas of responsibility activities under this MOU;
 - Their respective appropriate program managers will provide brief reports as necessary to their respective Units on the status of implementation of all cooperation activities listed within their areas of responsibility under this MOU;
 - The Parties will conduct joint mid-term reviews of the implementation of the MOU and consider further cooperation activities.





ARTICLE-10 ACKNOWLEDGEMENTS AND USE OF INSTITUTIONAL EMBLEMS

The Parties recognize that their involvement in joint cooperation activities under this MOU will be publicized. Therefore, the Parties understand that:

- (a) There will be a public acknowledgment of the role and contribution of each Party to cooperation projects in all public information documentation related to such cooperation;
- (b) Information related to activities under this MOU may be made available through customary channels according to the normal procedures and policies of each Party. Results derived from joint research projects shall be published with public acknowledgment of the role and contribution of each Party; and
- (c) The use of emblems of each Party in the documentation related to activities under this MOU will be in accordance with the current policies of each Party concerning such usage.

ARTICLE-11 TERM AND REVIEW OF THE MOU

- 11.1 This MOU shall be valid for an indefinite period, on the understanding that each Party is at liberty to terminate it at any time by giving 60 (sixty) days notice in writing to the other Parties.
- 11.2 MOU can be terminated by either Party, steps shall be taken by each Party to ensure that the termination is not prejudicial to any program or activity undertaken within the framework of the MOU.
- 11.3 This MOU may be amended at any time by mutual agreement of the Parties and the intention to amend any terms and/or conditions shall be communicated to the Parties in writing.

ARTICLE-12 MISCELLANEOUS

- 12.1 Any specific activity under this MOU shall be governed by a separate project document or written agreement/communication.
- 12.2 Any specific activity under this MOU shall be subject to the approval of the respective authorities of the Parties in accordance with their rules and procedure.
- 12.3 All information obtained and derived from the exchange of information either in writing or otherwise shall be treated as confidential during and after the expiration of this MOU unless otherwise mutually agreed upon in writing by the Parties.

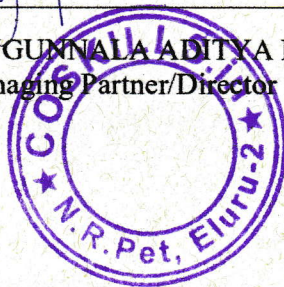
