Financial Aspects:

1. It has been mutually decided that the College shall pay a training fee of 8000 /- Rupees per student.
2. College must pay 30% of training fee after 1 week of the commencement of the training and 30% will be paid after 30 working days of the training program. The balance 40% will be paid after completion of Internship.

RESPONSIBILITIES OF THE PARTIES

3. We agreed to charge per students with an amount of **Rs.8000/-** (Rupees Eight Thousand only) towards fee for the training.

6. We are agreed to help the students with 40% of placements for the students who performed well during the training period.

- As such, any amendments made by the Parties will be applied to this Agreement.

ASSIGNMENT

- The Parties hereby agree not to assign any of the responsibilities in this Agreement to a third party unless consented to by both Parties in writing.

ENTIRE AGREEMENT

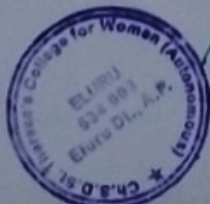




SEVERABILITY

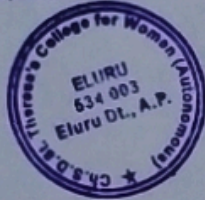


