



**CO-OPERATION**

1. The First and Second Parties have joined together for Starting **B.Sc.Agriculture & Rural Development, BBA - AVIATION SERVICES & AIR CARGO, B.Sc.Food Technology & Management Courses** From the Academic Year 2022-2023.

2. The **Memorandum of Understanding** is Valid for **B.Sc. Agriculture & Rural Development, BBA - Aviation Services & AIR CARGO & B.Sc.
